SUMMARY ANNUAL REPORT

LABORERS' DISTRICT COUNCIL OF WESTERN PENNSYLVANIA WELFARE FUND

This is a summary of the annual report of the Laborers' District Council of Western Pennsylvania Welfare Fund, EIN 25-6035806, Plan No. 501, for period January 01, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The Plan has contracts with HM Life Insurance Company, Metropolitan Life Insurance Company and Principal Life Insurance Company to pay stop loss, vision, life insurance, temporary disability and indemnity claims incurred under the terms of the Plan. The total premiums paid for the Plan Year ending December 31, 2024 were \$2,550,840.

BASIC FINANCIAL STATEMENT

The value of Plan assets, after subtracting liabilities of the Plan, was \$521,902,615 as of December 31, 2024, compared to \$478,138,234 as of January 01, 2024. During the Plan Year the plan experienced an increase in its net assets of \$43,764,381. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan Year, the Plan had total income of \$134,965,875, including employer contributions of \$106,753,854, employee contributions of \$941,707, realized gains of 706,403 from the sale of assets, and earnings from investments of \$26,563,911.

Plan expenses were \$91,204,494. These expenses included \$2,288,925 in administrative expenses, 438,022 in self insurance taxes, \$1,271,691 in investment expenses and \$87,602,856 in benefits paid to participants and beneficiaries.

- information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the Plan participates;

If you request a copy of the full annual report from the Plan Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
